# DISEC

## Mixed (Grade 6-12)

The Disarmament and International Security Committee is the arena where the world's most consequential security decisions are made. Nuclear weapons represent both the peak of military deterrence and the edge of humanity's self-destruction. The Treaty on the Non-Proliferation of Nuclear Weapons was once heralded as the cornerstone of global stability, a pact separating responsibility from recklessness. Yet decades later, the geopolitical landscape has shifted beyond recognition. New nuclear states have risen, strategic alliances have fractured, technological advancement has outpaced regulation, and entire regions now stand on the threshold of escalation.

In DISEC, delegates must navigate the delicate interplay of sovereign defense, global ethics, national pride, and historical mistrust. You will confront the uneasy truth: disarmament is easy to preach, but nearly impossible to enforce. Delegates must ask whether the NPT has safeguarded peace or merely cemented nuclear hierarchies that privilege a few and endanger many. Should the treaty be reformed to reflect modern realities, replaced with new frameworks, or defended as the last bulwark against nuclear chaos?

Here, diplomacy is high-stakes strategy. Speeches must be sharp, alliances must be calculated, and negotiation must be relentless.

In DISEC, one misjudgment is not an academic consequence, it is the spark that could alter the fate of the world.

# UNCSW

## JUNIOR (Grade 6-9)

Yet, historically, women's leadership in these processes has been overlooked, underrepresented, or actively suppressed.

UNCSW challenges delegates to reshape that narrative.

This committee invites young diplomats to design policy frameworks that place women at the center of peacebuilding: as legislators, negotiators, educators, and community leaders. Delegates will analyze the barriers created by tradition, trauma, and resource scarcity, while drafting solutions that ensure reconstruction is not only efficient, but equitable.

Here, diplomacy is not adversarial: it is empathetic, collaborative, and human-focused.

UNCSW proves that the future of governance is not just about who holds power, but how that power is shared.

# ECOSOC

## MIXED (grade 6-12)

Delegates must analyze the strategic motivations behind protectionism and fiscal aggression, while balancing the urgent need for inclusive development. Which nations benefit, which suffer, and who bears responsibility for restoring fairness?

This committee demands rigorous reasoning, persuasive diplomacy, and a willingness to negotiate beyond ideological comfort. ECOSOC invites delegates to design a world economy that is not dominated by the powerful, but shaped by cooperation, transparency, and equitable opportunity.

# AIPPM

# ICJ

## SENIOR (grade 9-12)

The International Court of Justice stands as the principal judicial organ of the United Nations—an institution where sovereignty is interpreted through law, and where diplomacy evolves into binding adjudication. In this chamber, evidence supersedes assertion, and clarity of reasoning becomes the ultimate instrument of influence.

The Frontier Dispute (Burkina Faso/Republic of Mali) places delegates at the heart of one of post-colonial Africa's most defining legal questions: How should borders drawn by colonial powers be understood, interpreted, and enforced when they no longer reflect ground realities? As two newly independent states confront territorial uncertainty along a volatile frontier, the Court must navigate the delicate balance between historical rights, the principle of *uti possidetis juris*, ethnic and cultural continuities, and the imperatives of regional stability.

Advocates must construct arguments rooted in international law—drawing on colonial-era administrative documents, historical cartography, regional treaties, and customary principles of boundary delimitation. Judges must examine every claim with judicial restraint, interrogate inconsistencies, and interpret the intent of colonial demarcations with dispassionate precision. Here, ambiguity is not an obstacle but a catalyst for rigorous legal reasoning.

The stakes are profound. A misinterpreted line on a map can ignite conflict, fracture communities, and destabilise a region. A correct interpretation, however, can secure peace, affirm sovereignty, and reinforce the rule of law in a continent still healing from the legacies of partition.

In the ICJ, your task is not to persuade through passion but to convince through doctrine. Your arguments must be meticulous. Your submissions must be grounded in precedent. Your reasoning must withstand judicial scrutiny.
